In pursuance of the Notification No.F.3(135)/Power/2010/Vol-II/1414-26 dated 19th October, 2023 of the Government of Tripura in Power Department the Commission is pleased to allow Engineering Officers serving under the Tripura State Electricity Corporation Limited (TSECL) in next Departmental Examination for Engineering Officers in Civil, Electrical and Mechanical Engineering Branches of all Departments of the State Government as provided in the "Tripura Engineering Officers Training and Departmental Examination Rules, 2008 (3<sup>rd</sup> Amendment, 2019)".

**To facilitate the Engineering Officers serving under the Tripura State Electricity Corporation Limited (TSECL) in next Departmental Examination for Engineering Officers in Civil, Electrical and Mechanical Engineering Branches of all Departments the scheduled date (15-11-2023) of said examination has been deferred and it will be held on & from 19-01-2024.**

Online Application Portal will be available on Commission's website from 10.11.2023 to 24.11.2023 (5.30 PM). After the closing date of submission of online application, the Commission will refer entire list of candidates to their concern Department for vetting of the Department towards permission to sit in the said Departmental Examination. The Commission will allow to sit the candidates in the examination only after receiving permission from their concern Department.

Application received after the closing date will not be entertained in any case. The list of eligible candidates, Programme of the Examination & Admission Certificate(s) of eligible candidates will be uploaded in the Commission's website (<http://www.tpsc.tripura.gov.in>) in due time.

**Online Application:**

(a) Applicants shall submit application through Online Application Portal only. The Commission will not entertain any offline application. Before submission of online application, instructions must be read by the candidate carefully.

(b) Online Application Portal will be available on Commission's website from 10.11.2023 to 24.11.2023 (5.30 PM). Before applying an applicant shall register his/her bio- data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz <http://www.tpsc.tripura.gov.in>. Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply using the OTPR User ID through the Commission's website.

(c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respects.


(d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against earlier application shall not be adjusted with latest application. For any doubt candidate can contact commission's helpline.

(e) Examination fee so deposited, is non refundable. Un-paid application will summarily be rejected.

(f) **The Candidates already applied in the instant Departmental Examination need not apply again for the same.**
