General Terms and Conditions

- 1) Eligible and interested bidders should drop complete and sealed tender in the tender box as stated in the 1st page of DNIT. Each and every page (including blank pages) of tender format should be signed by the bidder which will be part and parcel of the tender. Attested photocopies of valid documents as per direction of tender should invariably be enclosed with the tender and otherwise tender will be rejected. **Bidder must write the concerned DNIT number, bidder's own name and address very clearly in the cover of the sealed envelope. If any bidder do not write the concerned DNIT number, his / her tender will not be accepted and opened. Further if any bidder quote different / wrong DNIT number, his / her tender will be opened along with quoted tender and naturally that tender will also be rejected.**
Complete tender may be dropped in the tender box kept in the office chamber of undersigned or may be sent by post (registered with A/D). Tender must be dropped in the tender box or reach the undersigned positively on Dt. 08-06-2018 Upto 3.00 pm of office hours & days only.
- 2) Bidder must deposit required Earnest Money as stated in the 1st page of DNIT in the shape of D- call in favour of the undersigned from any nationalized Bank of India. **Without EMD in appropriate shape the tender will summarily be rejected.**
- 3) **Agreement:-** The bidder with lowest financial bid will be selected. The successful bidder will have to sign an Agreement with the Executive Engineer, RD Bishramganj Division for supply of materials within this divisional work for his/ her work on a Non Judicial Stamp paper of Rs 10/- (Rupees Ten) only within 15(fifteen) days from the date of approval of rate by the competent authority. Separate Agreement will be signed with separate bidder for different Block. If successful bidder fails to sign Agreement within stipulated period, the EMD to the full extent will be forfeited & they will be blacklisted for 2 years.
- 4) **Security money:-** 10% value of supply order issued in favour of successful bidder will be deducted from his/her bill as security money in such a manner that the total security deposit deducted against different supply order's may not exceed Rs. 20,000/- for particular bidder or an amount of Rs. 20,000/- may also be deposited in favour of EE, RD Bishramganj Division, Bishramganj in appropriate shape within 3(three) days from the date of issuance of supply order as security deposit as per convenience. The deposited EMD may also be converted as part of security money as per convenience of the successful bidder.
- 5) Bidder may be asked once or more by the undersigned for justification/ negotiation/ analysis of quoted rates after opening of the tender.
- 6)
 - I. If any bidder surrender their quoted rate immediate after dropping and before opening, 10% deposited EMD will be forfeited.
 - II. If surrenders after opening but before negotiation call, 25% will be forfeited and the bidder will not be allowed to participate in any future tender of this office.
 - III. If the bidder fails to respond negotiation call/ justify their quoted rate on the basis of analysis or surrender their rate after negotiation but before finalization, 50% EMD will be forfeited and the bidder will not be allowed to participate in any future tender of this office.
 - IV. If surrenders after approval of rates but before issuance of supply order, 75% EMD will be forfeited and the bidder will not be allowed to participate in any future tender of this office.
 - V. If surrenders after issuance of supply order or fails to sign agreement depositing security money in time, deposited EMD to the full extent will be forfeited and the bidder will not be allowed to participate in any future tender of this office.
 - VI. If after agreement, supplier/ contractor fails to arrange supply/ complete work as per specification in time, authority who has signed the agreement shall resign the agreement, cancel the issued work/ supply order and forfeit deposited earnest money / security money to the full extent after allowed period is over without serving any show cause notice to the supplier/ contractor. In addition to above punitive action, errant supplier / contractor will not be allowed to participate in any future tender of this office.

- VII. Further, if it is seen that supplier/ contractor supply/ execute the order partially and the authority get the work done engaging other agency at different rate, the difference of amount will also be incurred from the supplier/ contractor's pending bill/ Earnest money deposit/ security money deposit in connection with relevant work or any other work without any correspondence with the supplier/ contractor. In addition to above punitive action, errant supplier/ contractor will not be allowed to participate in any future tender of this office.
- 7) Approved rates will remain valid for **1(one)** year from the date of approval of rates without any price variation clause. No advance payment will be made and the payment will only be made if supplier/ contractor raise bill to the paying authority in appropriate fashion and if fund in the specific head of account is available with the paying authority only. Necessary statutory deduction (income tax, GST) will be deducted from the bill at source and necessary TDS will be provided by the undersigned.
 - 8) Rate must include all taxes and charges and to be quoted in the specified annexure of the tender form. Any overwriting / correction etc should duly be initialed by the bidder. Any clarification/ explanation if any regarding the tender should be sought from the undersigned before dropping of tender.
 - 9) Bidders may use extra sheet to explain specification/ design and enclose after signature with the tender.
 - 10) Quantity as mentioned in the DNIT is most tentative which may be nil / decrease / increase. Bidder shall have to execute ant ordered quantity.
 - 11) If last date of tender dropping become suddenly holiday or normal activities of office works get disrupted due to any strike/ natural calamity the last date of dropping may be deferred to next working date as per decision of the authority. In this regard decision of the tendering authority to defer or not to defer is final.
 - 12) Interested bidders may inspect the DNIT in the web site www.tenders.gov.in & www.rural.tripura.gov.in upto the specified period as mentioned in the first page of the tender form. Any clause not included in the DNIT but accepted by both the party mutually should also be a part and parcel of the agreement.
 - 13) Any conditional discount or other extraneous terms & conditions from bidder's end will not be entertained and tender will be declared as informal.
 - 14) Materials should be inspected by the departmental inspection committee / Engineer-in-charge. Decision of committee or Engineer-in-charge to accept / reject the supplied stores is final.
 - 15) Any ordered quantity should be executed positively within 07days from the date of issuance of supply order. The supplier should have sufficiently ready stock so that materials can be supplied as and when required.
 - 16) The earnest money of unsuccessful bidders will be refunded immediately after final acceptance of tender.
 - 17) Any clause not mentioned but subsequently mutually accepted will be a part & parcel of the agreement. Further any specification not in conformity of our requirement but subsequently mutually accepted may also be a part & parcel of the agreement.
 - 18) Materials shall be delivered at worksite upto motor point and transportation inclusive loading & unloading cost will be borne by bidders.
 - 19) If any supplied item is rejected by the engineer-in-charge, this should be replaced by the supplier at his/ her own risk and cost within 48 hours from rejection.
 - 20) Supply order will be issued by the tendering authority within the working jurisdiction of R. D. Bishramganj Division under Sepahijala District but the supply should be materialized in consultation with the concerned implementing officer of the work and the bill should be raised through the concerned I.O. only.

- 21) If necessary, total order may be divided amongst more than one bidder at the approved rates. It is not the right of bidder who has not been first lowest but discretion of the undersigned to take decision in this regard.
- 22) Tendering authority reserves the right to accept or reject any tender including first lowest bidder without assigning any reason.

SPECIAL TERMS AND CONDITION FOR PEA-GRAVEL

1. The Specified best quality pea-gravel (2 mm to 4.75 mm Nominal size) should be measured in the truck at the work site in presence of the concerned I/O. after the measurement the pea-gravel should be placed in the work site as per direction of the Engineer-in- charge.
2. Volume of quantum of pea-gravel will be measured as per following formula.
 - (i) Volume per trip will be ascertained as $L \times B \times D$ where
 L= Internal length of container in mt.
 B= Internal breath of container in mt.
 D= Depth of sand in the container in mt.
 - (ii) **Volume as assessed in (i) will be multiplied by 0.96** and in this way net volume per trip will be ascertained. The bidder should quote rate considering net volume.

An example is given below-

Suppose a truck having L= 2.5 m, B=1.6 m & D=1.0m has carried a trip. In this case net volume in this trip will be = $0.96 \times 2.5 \times 1.6 \times 1 \text{ m}^3 = 3.84 \text{ cum}$.

If quotationer quote rate Rs. y/ cum. For this trip gross payment after placing the pea-gravel in the worksite as per direction of in charge will be Rs.3.84 cum.

Gross payments include STCC (VAT), IT & cess etc.

Net payment which will be payable to the contractor will be deducting the GST, IT & Cess.

3. The quality of the pea-gravel should be such that there should not be other foreign matter, which may endanger the quality of the concrete for which this pea-gravel is to be used.
4. Before dropping tender, bidders may have a clear picture of 7 (seven) nos. Block within R.D Bishramganj Division under Sepahijala District & their road connectivity, condition of road, for unloading in the work site etc in details so that they can quote rates considering all above facts.
5. If any bidder fails to justify their quoted rates on the basis of analysis, their tender will be rejected and they will be barred to participate in future tender of this office. But their EMD will not be forfeited.
6. If any bidder suppress any fact in the tender and subsequently it is unearthed, their tender will be rejected and necessary punitive action including total forfeiture of EMD/ Security money/ Rescind of agreement/ Cancellation of supply order/ Barring from participation of future tender will be taken against them.
7. Forest royalty certificate must be enclosed along with bill.
8. Any bidder can participate for more than one area against single EMD. But if any bidder surrender rates of one area / block only his/her tender for other area / block will also be cancelled.
9. Any incomplete bid should be summarily being rejected.
10. Materials must be of 1st category & as per relevant IS specification. . All materials should fulfill the specification of Indian Standard Building materials / Field test.
11. If required materials may be tested in any institution / Govt. Department.
12. Bidder should submit a sample as & when it is asked by the authority which is non refundable. If quality of any supplied items differed from the submitted sample, materials will be rejected.
13. If required 1st lowest bidder may be asked to submit additional paper / test certificate during negotiation / clarification.
