On behalf of the Governor of Tripura, the Executive Engineer, RD Santirbazar Division invites Expression of interest in two bid system for supply of different categories of Construction Worker from the interested firms/agencies/Contractors/Individuals up to **3 PM of 20/11/2017** (office date and hour only) as per following terms condition as well as DNIT.

Financial bid should only contain the filled in rate quoting sheet. Technical bid and financial bid together to be inserted in one bigger envelop & must be addressed to the Executive Engineer, R.D. Santirbazar Division, Santirbazar, South Tripura indicating the DNIT Number, Name Of Item, Bidder's Name and Address on the envelop.**

8. The tentative date of opening of tender is **21/11/2017 at 3.30 PM**. Interested bidders or their representatives may remain present during opening of the tender.

If last date of dropping of tender happens to be a holiday or office work is affected due to any unforeseen circumstances, last date of dropping will automatically be extended up to next working day at respective time and accordingly opening date and time will be deferred. Opening date and time will be displayed in the office notice board if changed.
