6. Approved rates will remain valid for 1(one) year from the date of approval of rates without any price variation clause. No advance payment will be made and the payment will only be made if supplier/ fabricator raise bill to the paying authority in appropriate fashion and if fund in the specific head of account is available with the paying authority only. Necessary statutory deduction (income tax, sale tax, VAT) will be deducted from the bill at source and necessary TDS will be provided by the undersigned.
7. Rate must include all taxes and charges and to be quoted in the specified annexure of the tender form. Any overwriting / correction etc should duly be initialed by the bidder. Any clarification/ explanation if any regarding the tender should be sought from the undersigned before dropping of tender.
8. Bidders may use extra sheet to explain specification/ design and enclose after signature with the tender.
9. If last date of tender dropping become suddenly holiday or normal activities of office works get disrupted due to any strike/ natural calamity the last date of dropping may be deferred to next working date as per decision of the authority. Special Terms and Conditions of manufacturing & supplying of different categories steel items

1. Supplier should arrange supply in the any worksite within the Sepahijala area as per instruction in the supply order and necessary transportation, loading, unloading, weighing, erection if applicable along with other taxes should be included into the rate.
2. Inspection:- Product will be inspected by the departmental inspection committee. If any complete items is rejected by the Engineer-in-Charge said should be replaced by the fabrication at his / her own cost & risk within 48 hours from rejection.
3. Work may be splitted amongst more than one bidder at the approved rate if concerned authority desires. But it should not be treated as the right of bidder.
4. Finished product shall have to be painted with 2 (two) primer coat of ready mixed red oxide as per relevant IS specification. For this work no separate payment will be made.
5. Before dropping of tender, bidder may consult of this establishment for clarification/ explanation / interpretation of any specification/ claim/ drawing.
6. Before dropping of tender, bidders may have a clear picture of entire district/block area including the location their road connectivity, condition of road, availability of labourers for unloading etc. in details so that they can quote rates considering all above facts.
7. If any bidder suppress any fact in the tender and subsequently it is unearthed, their tender will be rejected and necessary punitive action including total forfeiture of EMD/ Security money/ Rescind of agreement/ Cancellation of supply order/ Barring from participation of future tender will be taken against them.

9. Fabrication of tubular truss:-
 - i) Only black pipe will be supplied from the department. In case of rejection of fabricated work done by fabricator the cost of departmental materials so involved should be recovered at double of issue rate from the fabricator along with other punitive action. Balance store materials if any lying with fabricator after completion of the work or incase of failure (and if it is supplied from the District store), must be returned by the fabricators to the store at his own cost positively. If they fail to return the excess materials cost of materials at the double issue rate will be recovered with punitive action as per rule.

ii) Cost of carrying , loading, unloading of raw materials from District store, the loading, carrying of the finished products and fitting fixing of the same in the worksite should be included in the rate. Departmental supply of related raw materials (Black pipe) will be made as per actual verified quantities. Necessary other materials including welding sticks, tools and plants etc required for fabrication shall be arranged by the fabricator at his own cost.

iii) For any shortage/ theft/ damage of stores issued to the fabricator, recovery at double rate will be made.

iv) No wastage of materials will be allowed. Materials will be issued based on actual consumption of store materials, which will be certified by the supervising Officer.

v) Finished product should not left open without instruction of authority, it must be kept at the custody of fabricator.

vi) Fabrication must be in conformity with enclosed design & drawing (For both fabrication & manufacturing).

vii) All the members of the structure shall have to be painted with 2 (two) primer coat of ready mixed red oxide as per relevant IS specification & base plate will be painted with coal tar. For this work no separate payment will be made (For both fabrication & manufacturing).

viii) All sides of joint sections of the whole structure should be welded with 6 mm continuous fillet welding and no portion of the joint section should be left un welded (For both fabrication & manufacturing).

11. Specification of steel window (OBB pattern):

- b. Shutter frame will made of 20x20x3mm Z bar,
- c. For horizontal batten, MS flat 20x5 mm size is to be used,

- f. Size of hold fast (4 nos) will be 180x25x5mm,
- g. Size of butt hinges (4 nos) will be 75x47x1.7mm,
- h. For grills MS flat of size 18mmx5mm is to be used,
- i. Total weight of window with all accessories =50 kg+5%,
- j. Window should be of side hung with double shutter,
- k. Locking arrangement should be provided in the middle of window.
- l. Handle of standard quality should be provided.
