3.0 Background:

The Pradhan Mantri Awaas Yojana - Gramin (PMAY-G) is a flagship scheme of the Government of India launched to provide pucca houses with basic amenities to all houseless households and those living in kutcha and dilapidated houses in rural areas. The scheme aims to achieve the objective of 'Housing for All'. The implementation of the scheme in Tripura aims at not just providing shelter, but also ensuring quality, durability, and convergence with other schemes for holistic development.

4.0 Aims & Objectives:

The objective of undertaking the evaluation study is to analyze the implementation and impact of PMAY-G in the Gram Panchayat areas of Tripura, in both financial and physical terms, and provide recommendations for improving outcomes, ensuring better resource utilization and enhancing beneficiary satisfaction. Also, the study intends to highlight the success stories associated with the program.

Evaluation study on the implementation of the Pradhan Mantri Awaas Yojana -Gramin (PMAY-G) in Tripura

TERMS OF REFERENCE

1. BACKGROUND

PMAY-G was launched to provide pucca houses to all houseless households and those living in kutcha or dilapidated houses in rural areas. The scheme aims to ensure adequate shelter for rural households, improving their living standards.

2. <u>OBJECTIVES</u>

The objective of undertaking the evaluation study is to analyze the implementation and impact of PMAY-G in the Gram Panchayat areas of Tripura, in both financial and physical terms, and provide recommendations for improving outcomes, ensuring better resource utilization and enhancing beneficiary satisfaction. Also, the study intends to highlight the success stories associated with the program.

3. METHODOLOGY

- a. A field survey of the Gram Panchayat areas of the state choosing all the 8 districts will be conducted. During the visit the team will interact with the stakeholders / PRI members / local public etc. at District / Block / GP levels and also visit the houses of the PMAY-G beneficiaries. Atleast 3 Blocks in each district and atleast 4 GPs within each Block will be selected randomly for field visit.
- b. Interaction programs with the various stakeholders / PRI members may be undertaken.

4. TIME SCHEDULE

A draft appraisal report would be submitted within 3 months of the date of signing of agreement. Feedback from the Districts should be taken into account by the Consultant in the final report in a substantive manner and for the record. The consultant will submit the final report within 4 months of the date of signing of agreement, after taking into account the comments of the stakeholders. Four hard copies along with soft copy of the Final Review Report shall be submitted to Rural Development Department (RDD), Govt. of Tripura within a period of four months from the date of signing of agreement.

i. Assess the impact of PMAY-G on the living standards of rural households, including improvements in health, sanitation, and overall well-being.

- ii. Analyze the effectiveness of the scheme's implementation mechanisms, including the role of state governments, district administrations, and community participation.
- iii. Provide recommendations for improving the implementation and monitoring of PMAY-G, including suggestions for better utilization of resources and enhancing the quality of construction.
