General Terms and Conditions

1. Eligible and interested bidders should drop complete and sealed tender in the tender box as stated in the 1st page of DNIT. Each and every page (including blank pages) of tender format should be signed by the bidder which will be part and parcel of the tender. Attested photocopies of valid documents as per direction of tender should invariably be enclosed with the tender and otherwise the tender will be rejected. **However after opening of tender, tendering authority reserves the right to ask 1st lowest bidder to submit required paper if not enclosed / asked along with tender.** No unwanted paper should be enclosed with tender. Bidder must write the concerned DNIT number, bidder's own name and address very clearly in the cover of the sealed envelope. Tender complete and sealed may be sent to the tendering authority by post (registered with A/D) which should invariably be reached to the tendering authority within specified period (**upto 3.00 pm Dt. 08-06-2018**) as stated in the 1st page of tender form.
2. Bidder must deposit required Earnest Money as stated in the 1st page of DNIT in the shape of **D call** in favour of the undersigned from any nationalized Bank. Without EMD in appropriate shape the tender will summarily be rejected.
3. i) **Agreement:-** The successful bidder will have to sign an Agreement for supply of materials within this divisional work on a Non Judicial Stamp paper of Rs 10/- (Rupees Ten) only within 15(fifteen) days from the date of approval of rate by the competent authority. If successful bidder fails to sign Agreement within stipulated period, the EMD to the full extent will be forfeited & they will be blacklisted for 2 years.
ii) **Security money:-** 10% value of supply order issued in favour of successful bidder will be deducted from his/her bill as security money in such a manner that the total security deposit deducted against different supply order's may not exceed ₹ 35,000/- for particular bidder or an amount of ₹ 35,000/- may also be deposited in favour of EE, RD Bishramganj Division, Bishramganj in appropriate shape within 7(seven) days from the date of issuance of supply order as security deposit as per convenience. The deposited EMD may also be converted as part of security money as per convenience of the successful bidder.
4. Bidder may be asked once or more by the undersigned for justification/ negotiation/ analysis of quoted rates after opening of the tender.

5. . **Penalty:** Penalty will be imposed for withdrawing of tender, revision of rates after dropping of tender, violation of term condition during clarification and clarification, non execution of agreement in time, delay to execute supply order, non execution of supply order, violation of term condition of tender and agreement, suppression of fact in tender. The range of penalty includes forfeiture of earnest money, security money, imposing liquidated damage @ 1% per day subject to maximum 10%, withdrawing of ordered quantity and procurement by alternative arrangement at the cost of errant supplier and extra cost to be recovered from errant supplier's security money, pending bills or by any other legal procedure, cancellation of agreement and procurement of ordered stores by suitable alternative arrangement at the cost of errant suppliers, blacklisting of errant suppliers. The tendering authority reserves the sole right to decide the penalty.

Penalty will be imposed for the default as per the following manners: -

5	Failed to attend in the negotiation.	100% of the EMD will be forfeited and blacklisted for next one year.
6	After negotiation, failed to sign the agreement in the specific time.	100% the EMD will be forfeited and blacklisted for next two years.
7	After signing of agreement failed to supply the materials as per supply orders within stipulated delivery period including extension on valid reason.	The balance ordered quantity of store , which the errant supplier failed to supply will be slashed and will be procured through other alternative arrangement. The EMD & security money will be forfeited and no payment will be paid to the supplier for supplied quantity if any and will be blacklisted as follows- a) Failed to supply materials less than 50% - Supplier will be blacklisted for next 5 years. b) Supplied more than 50% but less than 60% - Supplier will be blacklisted for next 4 years. c) Supplied more than 60% but less than 70% - Supplier will be blacklisted for next 3 years. d) Supplied more than 70% but less than 80% - Supplier will be blacklisted for next 2 years. e) Supplied more than 80% but less than 90% - Supplier will be blacklisted for next 1 year. f) Supplied more than 90% but less than permissible limit as per DNIT then the supplier will not be blacklisted .

6. Approved rates will remain valid for 1(one) year from the date of approval of rates without any price variation clause. No advance payment will be made and the payment will only be made if supplier/ contractor raise bill to the paying authority in appropriate fashion and if fund in the specific head of account is available with the paying authority only. Necessary statutory deduction (income tax, sale tax, GST) will be deducted from the bill at source and necessary TDS will be provided by the undersigned.

7. Rate must include all taxes and charges and to be quoted in the specified annexure of the tender form. Any overwriting / correction etc should duly be initialed by the bidder. Any clarification/ explanation if any regarding the tender should be sought from the undersigned before dropping of tender.
8. Bidders may use extra sheet to explain specification/ design and enclose after signature with the tender.
9. Quantity as mentioned in the DNIT is most tentative which may be nil/ decrease/ increase. Bidder shall have to execute any ordered quantity.
10. If last date of tender dropping become suddenly holiday or normal activities of office works get disrupted due to any strike/ natural calamity the last date of dropping may be deferred to next working date as per decision of the authority. In this regard decision of the tendering authority to defer or not to defer is final.
11. Interested bidders may inspect the DNIT in the office of the tendering authority upto the specified period as mentioned in the first page of the tender form. Any clause not included in the DNIT but accepted by both the party mutually should also be a part and parcel of the agreement.
12. If necessary, total order may be divided amongst more than one bidder at the approved rates. It is not the right of bidder who has not been first lowest but discretion of the undersigned to take decision in this regard.
13. Any conditional discount or other extraneous terms & conditions from bidder's end will not be entertained and tender will be declared as informal.
14. Materials should be inspected by the departmental inspection committee / Engineer-in-charge. Decision of committee or Engineer-in-charge to accept / reject the supplied stores is final.
15. The work should be executed positively within 15 days from the date of issuance of work/supply order. The bidder should have sufficiently ready stock so that materials can be utilized as and when required.
16. Any tender not complying with the requirement / fulfill the terms and conditions of the tender will be declared as informal.
17. Tendering authority reserves the right to accept or reject any tender including first lowest bidder without assigning any reason.
18. The earnest money of unsuccessful bidders will be refunded immediately after final acceptance of tender.
19. Any clause not mentioned but subsequently mutually accepted will be a part & parcel of the agreement. Further any specification not in conformity of our requirement but subsequently mutually accepted may also be a part & parcel of the agreement.
20. Any incomplete bid should be summarily be rejected.
21. If Tendering authority desire, department can issue electric wire of different specification available in RD store as per issue rates and the amount will be recovered from the bill of the respective suppliers.

Special Terms and Conditions for Internal Electrification

- 1) Materials should be supplied as per specification of ISI.
- 2) Rates are including carrying GST/IT, loading, weighing, counting, stacking, fitting fixing charges etc.
- 3) If any work is rejected it should be replaced by the supplier/worker at his/ her own risk & cost within 48 hrs from rejection.
- 4) Payment will be made after receipt of materials.
- 5) GST & Income taxes as per rule will be deducted from bill and necessary TDS will be provided by the undersigned
- 6) Quantity may increase or decrease.
- 7) Internal Electrification Work should be taken within 15 days from the date of issuance of order.
- 8) Quoted rate should valid upto one year from the date of approval of rates within any price variation clause.
- 9) Work order will be issued by the undersigned of Sepahijala District.
- 10) The bidder should have sufficient ready stock so that work can be start as and when required.
- 11) If after agreement, supplier fails to arrange supply/ complete work as per specification in time, authority who has signed the agreement shall rescind the agreement, cancel the issued work/ supply order and forfeit deposited earnest money/ security money to the full extent after allowed period is over without serving any show cause notice to the supplier/contractor.
- 12) After completion of I.E work, Contractor should arrange of his own cost for testing before getting of power service connection.
- 13) If any complaints is found within one year after completion of work, the supplier/ contractor should rectify the said at his/her own cost within three days of receipt of complain.
- 14) If supplier/ contractor fail to complete the work, lowest approved rate may be offered to other bidder for early completion of work.
